(ii) Registered as a Nurse or Nurse and Midwife (Registered Nurse or Registered Nurse and Registered Mid-wife) from State Nursing Council; and (iii) One year’s experience in minimum fifty bedded Hospital after acquiring the educational qualification mentioned at II(i) above”.
